

AGREEMENT

Between the Swedish Association of University Teachers (SULF) and the Irish Federation of University Teachers (IFUT) to Provide Services for Members of the SULF Working Temporarily in the Irish Republic and Members of the IFUT Working Temporarily in Sweden.

1. This is a reciprocal agreement between the Swedish Association of University Teachers (SULF) and the Irish Federation of University Teachers (IFUT) that provides for services for (a) members of SULF working temporarily in institutions in the Irish Republic where IFUT is recognised and (b) for members of IFUT working temporarily in institutions of higher education in Sweden where SULF is recognised but where visiting academic staff are not eligible for full union membership.
2. Affiliate members receiving services in the host country must remain members in good standing of their home organization and continue to pay appropriate fees. Affiliate members shall register with the host union which will inform the home union of their registration.
3. Members of the IFUT working in Sweden who do not become regular members of SULF shall be eligible for complimentary membership in SULF as “affiliate members.” The period of complimentary affiliate membership for any individual shall not exceed two (2) years.
 - A. When members of the IFUT are arranging temporary employment in Sweden, the IFUT will direct them to SULF, which will provide information, advice and informal representation, if required, to determine the terms of the contract of employment of the affiliate members and any other employment issues arising from the appointment. Such assistance may be provided either by the appropriate full-time official at the national level or officers of SULF at the institution.
 - B. SULF branches may, at their absolute discretion, invite affiliate members to attend general meetings and to take part in discussions.
 - C. Affiliate members may take part in national activities of SULF by invitation from an appropriate official.
 - D. Affiliate members will not take part in elections for local or national officers of the SULF.
 - E. Affiliate members cannot take part in SULF ballots concerning industrial action.
 - F. Affiliate members will be entitled to receive the SULF magazine

Universitetslararen and SULF newsletter while working in Sweden.

G. Affiliate members shall have access to any financial services available to members of SULF in Sweden, subject to any limitations required by the providers of such services.

H. Affiliate members shall not have any automatic entitlement to professional legal advice and representation. Where a significant legal principle is identified by the national Executive Committee of SULF, discussions will take place between the two unions and an agreement reached on liability for costs arising from any legal advice or representation. Neither union is obliged, by virtue of this agreement, to provide representational services and/or financial assistance for such services. For the avoidance of doubt, this clause does not override the residual discretion of the national Executive Committee of SULF to decide whether or not to provide legal advice or representation.

4. Members of SULF working in the Irish Republic who do not become regular members of the IFUT shall be eligible for complimentary membership in the IFUT as “affiliate members.” The period of complimentary affiliate membership for any individual shall not exceed two (2) years.

A. When members of SULF are arranging temporary employment in the Irish Republic, SULF will direct them to the IFUT, which will provide information, advice and informal representation, if required, to determine the terms of the contract of employment of the affiliate members and any other employment issues arising from the appointment. Such assistance may be provided either by the appropriate full-time official at the national level or officers of the IFUT at the institution.

B. IFUT branches may, at their absolute discretion, invite affiliate members to attend general meetings and to take part in discussions.

C. Affiliate members may take part in national activities of the IFUT by invitation from an appropriate official.

D. Affiliate members will not take part in elections for local or national officers of the IFUT.

E. Affiliate members cannot take part in IFUT ballots concerning industrial action.

F. Affiliate members will be entitled to receive the IFUT *Bulletin* while working in the Irish Republic.

G. Affiliate members shall have access to any financial services available to members of the IFUT in the Irish Republic, subject to any limitations required by

the providers of such services.

H. Affiliate members shall not have an automatic entitlement to professional legal advice and representation. Where a significant legal principle is identified by the IFUT, discussions will take place between the two organisations and an agreement reached on liability for costs arising from any legal advice or representation. Neither union is obliged, by virtue of this agreement, to provide representational services and/or financial assistance for such services. This clause does not override the residual discretion of the IFUT to decide whether or not to provide legal advice or representation.

- 5. The IFUT and SULF both agree to promote this agreement within their countries as the Transnational Higher Education Individual Affiliate Membership Plan.
- 6. Services provided by both the IFUT and SULF to affiliate members shall be borne in consideration for similar services from the other union under this reciprocal agreement.
- 7. This agreement may be terminated by either party by giving the other six (6) months written notice. At the end of the period of such notice, no affiliate member is entitled to any benefits under the terms of this agreement.
