

## Are you on a Fixed Term Contract? Hourly Paid? On a Casual Contract?

## **KNOW YOUR RIGHTS**

Many lectures, researchers, tutors, teaching assistants and fellows in our universities are hired on fixed term contracts, sometimes for many years.

The Irish Federation of Univerity Teachers secured agreement with university employers for lecturing staff so that they may claim a CID (Contract of Indefinite Duration) after 2 years. This is known as the Cush Agreement.

There is also legislation protecting all staff on fixed term contracts, the Protection of Employees (Fixed Term Work) Act 2003, which was designed to protect workers from exploitation. This enables workers to claim a CID after 4 years on successive fixed term contracts.

By utilising both the Cush Agreement and this legislation, IFUT pursues cases on behalf of our members each year which results in many of our members securing a CID.

IFUT has also secured redundancy pay for workers who leave the employment at the end of a fixed term contract.

For casual and hourly paid staff IFUT also offers advice and representation where those staff believe they are being treated less favourably than their full time colleagues. The Protection of Employees (Part Time Work) Act 2001 prohibits discrimination against workers on part time contracts, which may include hourly paid and casual workers. In IFUT we understand that there is a difference between having rights and vindicating those rights. It is through their union that workers in Irish Universities secure decent terms and conditions of employment and tackle unfair practices.

Many workers leave their employment unaware of their rights, including their possible entitlement to a CID or enhanced redundancy pay for IFUT members, the requirement of the employer to try to seek alternative work, or the time limits to take cases for unfair dismissals.
